Admission Program for Degree Engineering, Degree / Diploma Pharmacy, Degree Architecture and MBA / MCA for wards of J&K migrants and Kashmiri Pandit / Kashmiri Hindu Families (Non-Migrants) living in Kashmir valley (Admission Year-2024)

Applications are invited from the wards of J&K migrants and Kashmiri Pandit/Kashmiri Hindu Families (Non-Migrants) living in Kashmir valley as per the provisions of the MHRD and Government of Gujarat, Education Department Notifications for admission to first year Degree Engineering, Degree/Diploma Pharmacy, Degree Architecture courses after 12th (HSC) Science Stream and MBA/MCA after graduation in Govt. /Grant-in-aid/Self-financed institutes (two seats per institute). Eligibility for admission: For Degree Engineering, Degree/ Diploma Pharmacy, Degree Architecture and MBA/MCA courses shall be as per prevailing Notifications. Students applying under this category for admissions to the first year Degree Engineering, Degree/ Diploma Pharmacy are exempted from GUJCET-2024, admissions to the MBA/MCA are exempted from CMAT-2024. Eligible and interested candidates should apply in the prescribed application form available on the website along with self attested copies of relevant documents and a demand draft for Rs. 350/- for Degree Engineering, Degree/Diploma Pharmacy, Degree Architecture courses in favor of “**GTERS-ACPC FEE**” payable at Ahmedabad so as to reach the Committee on or before **Dt.:16/08/2024 up to 05.30 p.m.** Separate application form to be filled for Degree Engineering and Degree/ Diploma Pharmacy and Degree Architecture courses with D.D. of Rs. 350/- per each form. For MBA/MCA course D.D. of Rs. 500/- per each form and Rs.750/- for MBC (applying for both MBA and MCA courses). It is mandatory to produce the domicile Certificate issued from the competent authority along with application for Kashmiri Pandit/Kashmiri Hindu Families (Non-Migrants) living in Kashmir valley. The domicile certificate is not required for the J&K migrants, which may be noted. Applications received after the time limit shall not be entertained. Merit list of all eligible candidates shall be placed on the website on **Dt.:22-08-2024**. For the Counseling program will be held on **Dt.:30.08.2024** from 11.00 a.m. at the office of the Committee. No individual call letter will be issued. Candidates, whose names appeared in the merit list, shall remain present with all original documents & necessary token tuition fee (Rs.1500/- for Govt. Grant-in-aid institutes & Rs. 20,000/- for self-financed institutes) at their own cost. The candidate who remains present without original documents shall not be allowed to take part in the counseling.
