No.GH/SH/76/2025/PVS/102020/285/S :- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Master of Business Administration [MBA] Course (Regulation of Admission and Payment of Fees) Rules, 2020, namely: -

1. Short Title and Commencement. -

- (1) These rules may be called the Master of Business Administration Course (Regulation of Admission and Payment of Fees) (Amendment) Rules, 2025.
- (2) They shall come into force on the date of their publication in the *Official Gazette*

2. In the Master of Business Administration Course (Regulation of Admission and Payment of Fees) Rules, 2020, in rule 12, in para C, for clause (2), the following clause shall be substituted, namely: -

(2) The merit list of the Government seats of CoE shall be as per para A of this rule. However, for the cases as mentioned in sub-rule (1) above, the separate merit list shall be prepared for Government seats as provided in undertaking by the CoE institute on the basis of common merit marks prepared by the Admission Committee. The merit list shall have minimum 60% weightage of percentile scored by candidate in CAT exam of corresponding academic year, with maximum 20% weightage of marks scored on the basis of 100 scored after conducting personal interview by expert panel appointed by the Admission Committee, maximum 10% weightage of marks scored on the basis of 100 scored after Theme development presentation or Group discussion evaluated by expert panel appointed by the Admission Committee and maximum 10% weightage on the basis of 100 points based on the academic performance of candidate in terms of percentage at the level of SSC, HSC or equivalent and undergraduate program from approved board/recognized university. The academic performance shall be calculated with 20% weightage

of SSC, 30% weightage of HSC or equivalent and 50% weightage of under graduate program. In case of the result of undergraduate examination is awaited, the result of the immediate previous exam shall be considered. The criteria for deciding merit order in case of students having equal merit marks shall be in the following sequence namely: -

- (i) Percentile score obtained in CAT exam,
- (ii) Percentage Score obtained in HSC or equivalent exam.
- (iii) Percentage score obtained in SSC exam.
