No. GH/SH/23/2024/PVS/102020/471/S: In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Master of Planning Courses (Regulation of Admission and Payment of Fees) Rules, 2020, namely:

1. Short Title and Commencement. -

- (1) These rules may be called the Master of Planning Courses (Regulation of Admission and Payment of Fees) (Amendment) Rules, 2024.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Master of Planning Courses (Regulation of Admission and Payment of Fees) Rules, 2020 (hereinafter referred to as "the said rules"), in rule 2, in sub-rule (1), after clause (e), the following clause shall be inserted, namely:-
- "(ee) "CoE" means the Centre of Excellence as defined in clause (d) of rule 2 of the Gujarat Professional Technical Educational Colleges or Institutions (Procedure for Declaration of Centre of Excellence) Rules, 2020.".
- 3. In the said rules, in rule 5.-
- (i) for sub-rule (1), the following sub-rule shall be substituted, namely: -
- "(1) The candidate shall have passed the qualifying examination, as specified in column 4 of the Appendix.";
- (ii) in sub-rule (2), for clause (a), the following clause shall be substituted, namely:-
- "(a) passed the qualifying examination, as specified in column 4 of the Appendix."
- **4.** In the said rules, in rule 12, after para B, the following para shall be added, namely:-

"C. Government Seats of "Centre of Excellence"

Notwithstanding anything contained in these rules the admission process for the Government Seats of the Centre of Excellence shall be carried in the following manner, namely:-

- (1) The registration shall be carried out separately among all the CoE if the merit method or common entrance test of relevant credibility at the National or State level is not as per the merit preparation mentioned in para A of this rule or as may be directed/decided by the Government.
- (2) The merit list of the Government seats of CoE shall be as per para A of this rule. However, for the cases as mentioned in sub-rule (1) above, the merit list shall be prepared on the basis of the common entrance test of relevant credibility at the National or State level as provided by the respective Institute or University.
- (3) These seats shall be allotted to the candidates who have passed the qualifying examination from the eligible Board or University located in the State of Gujarat as

per provisions of rule 5. The candidates who have passed the qualifying examination as per provisions of rule 5 from the eligible Board and University located outside the State of Gujarat and possess domicile of the State of Gujarat shall also be eligible for the admission.

- (4) After completion of online round/s, the Committee shall declare the vacancy on the website. The vacancy due to non-allotment and non-reporting shall be converted into vacant seats whose admission shall be carried out at institute level as mentioned in rule 21.".
- 5. In the said rules, in rule 22, after sub-rule (2), the following sub-rule shall be added, namely: -
- (3) Each unaided college or institution including notified "Centre of Excellence" shall submit all the details with necessary documents as prescribed by the Admission Committee after completion of admission as announced by the Admission Committee in stipulated period as notified by the Admission Committee. After verification of the admissions under all quota, the Admission Committee shall issue the final admission list to the respective institute. No admission shall be treated as valid admission unless the name of the candidate is mentioned in the final admission list issued by the Admission Committee. The University shall not enrol any candidate whose name is not mentioned in the admitted list issued by the Admission Committee.
- **6.** In the said rules, for column 4 of the appendix, the following column 4 shall be substituted, namely:-

Eligibility

- (1) Bachelor of Architecture, or
- (2) B.E./B. Tech (Civil Engineering), or
- (3) Bachelor of Planning, or
- (4) Post graduation in Geography or Economics or Sociology or equivalent qualification.
