GH/SH/15/2024/PVS/102020/13/S ::- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Bachelor of Engineering and Technology (Regulation of Admission and Payment of Fees) Rules, 2020, namely:-

1. Short Title and Commencement. -

- 1) These rules may be called the Bachelor of Engineering and Technology (Regulation of Admission and Payment of Fees) (Amendment) Rules, 2024.
- 2) They shall come into force on the date of their publication in the official Gazette.

2. In the Bachelor of Engineering and Technology(Regulation of Admission and Payment of Fees)Rules,2020(hereinafter referred to as “the said rules”), in rule 2, -

- (i) after clause (c), the following clause shall be inserted, namely:-
“(cc)” “CoE” means Centre of Excellence as defined in clause (d) of rule 2 of the Gujarat Professional Technical Education Colleges or Institutions(Procedure for Declaration of Centre of Excellence)Rules,2020;”
- (ii) after clause (i),the following clause shall be inserted, namely :-
“(ii) “Improvement Exam” means qualifying examination appeared / passed by candidate who have already declared passed by the Board as per the provision by the respective board;”
- (iii) after clause (o),the following clause shall be inserted, namely :-
“(oo) “Supplementary Exam” means qualifying examination appeared / passed by candidate who have not been declared passed by the Board as per the provision by the respective Board.

3. In the said rules, in rule 4 in sub-rule (1), in para B, for the first proviso, the

following proviso shall be substituted, namely :-

“Provided that the Government Seats shall be available for online admission as per the counselling rounds declared by the Admission Committee from time to time.”.

4. In the said rules, in rule 5 , in para A,-

- (i) for sub-rule (7), the following sub-rule shall be substituted, namely :-

“ (7) A candidate who has already passed the qualifying examination and appeared for an improvement examination of the same Board and has appeared in GUJCET examination of corresponding year shall be eligible for the admission in subsequent online admission rounds provided that candidate has completed registration within a period as notified by the Admission Committee. Such revised merit number of registered candidates shall be applicable on available seats in subsequent online admission round/s.”;

- (ii) After sub-rule(7), the following sub-rule shall be added, namely:-

“(8) A candidate who has passed the qualifying examination after appearing in the supplementary examination conducted by the Board shall be eligible for admission in the current academic year on the vacancy arises after offering the seats to the candidates whose name appears in the merit list prepared for Government Seats in the earlier round.”.

5. In the said rules, in rule 11,-

- (i) in para A, after sub-rule (4), the following sub-rule shall be added, namely:-

"(5) After the declaration of the result of the improvement exam by the respective Board, the merit list prepared as per sub-rule (1) shall be revised and the meritorious candidate shall be included in immediate next online round of admission. In such case, all candidate shall be placed at an appropriate order in the merit list for subsequent online rounds of Government Seats.”.

- (ii) after para B, the following para shall be inserted, namely:-

“C. Government Seats of Centre of Excellence:

Notwithstanding anything contain in these rules, the admission process for Government Seats of the Centre of Excellence shall be carried in the following manner, namely:-

- (1) The registration shall be carried out separately among all the CoE, if the merit method or common entrance test of relevant creditability at national or state level is not as per the merit mentioned in sub-rule (1) of para A of this rule.

- (2) The merit list of the Government seats of notified "CoE" shall be prepared on the basis of the details of merit based on common entrance test of relevant creditability at the national or state level or merit mentioned in sub-rule (1) of para A of rule 11 provided by respective Institute or University.
- (3) These seats shall be allotted to the candidates who have passed the qualifying examination from the eligible Board or University located in the state of Gujarat as per provisions of rule 5. The candidates who have passed the qualifying examination as per provisions of rule 5 from the eligible Board and University located outside the State of Gujarat and possess domicile of the State of Gujarat shall also be eligible for the admission.
- (4) After completion of online round/s, the Committee shall declare the vacancy on website. The vacancy due to non-allotment and non-reporting shall be converted into vacant seats whose admission shall be carried out at institute level as mentioned in rule 19."

6. In the said rules, in rule 12 , for sub-rule(2), the following sub-rule shall be substituted, namely:-

- "(2) The candidate who was declared failed initially in the Qualifying Examination, but later on declared passed after rechecking of marks by the respective Board, such candidate shall be allowed to apply in the subsequent round of the admission process provided the counselling for the academic year is not over. The candidate shall produce the rechecking and revised marks letter to that effect issued by the competent authority or the corrected mark-sheet issued by the respective Board, within seven days of the receipt of letter or, as the case may be, corrected mark-sheet to the Admission Committee. In such case, the candidate shall be placed at an appropriate order in the merit list."

7. In the said rules, in rule 20 , after sub-rule (2), the following sub-rule shall be inserted, namely:-

- "(3) Each unaided college or institution including notified "Centre of Excellence" shall submit all the details with necessary documents as prescribed by the Admission Committee after completion of admission as announced by the admission committee in stipulated period as notified by the Admission Committee. After verification of the admissions under all quota, the Admission Committee shall issue the final admission

list to the respective institute. No admission shall be treated as valid admission unless the name of the candidate mentioned in final admission list issued by the Admission Committee. The University shall not enrol any candidate whose name is not mentioned in the admitted list issued by Admission Committee.”.
