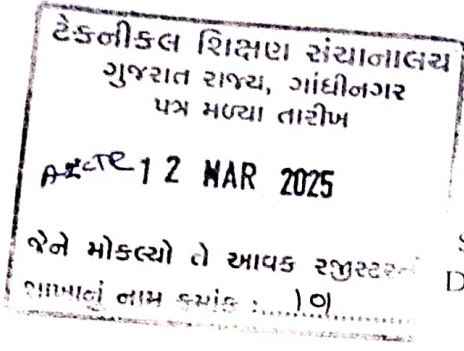

NO.GH/SH/18/2025/PVS/102020/61/S: In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat, hereby makes the following rules further to amend the Diploma In Engineering Courses to Bachelor of Engineering and Technology Courses (Regulation of Admission and Payment of Fees) Rules, 2024, namely:-

1. Short Title and commencement.

- (1) These rules may be called the Diploma in Engineering Courses to Bachelor of Engineering and Technology Courses (Regulation of Admission and Payment of Fees) (Amendment) Rules, 2025.
- (2) They shall come into force on the date of their publication in the *Official Gazette*.

2. In the Diploma in Engineering Courses to Bachelor of Engineering and Technology Courses (Regulation of Admission and Payment of Fees) Rules, 2024 (hereinafter referred to as "the said rules"), in rule 5,

(1) in para A,-

- (i) in clause (i), for the words "in immediate previous academic year", the words "in any academic year" shall be substituted;
- (ii) clause (ii) shall be deleted;
- (iii) in clause (iii), for the words "in immediate previous academic year", the words "in any academic year" shall be substituted;

(2) in para B,-

(i) in clause (1), for the words "in immediate previous academic year", the words "in any academic year" shall be substituted;

(ii) in clause (2), for the words "in immediate previous academic year", the words "in any academic year" shall be substituted.

3. In the said rules, in rule 12, in para A, in clause (1), the words "priority shall be given to the candidates who have cleared diploma in the immediate previous academic year" shall be deleted.
