Instructions for Offline Counseling to Vacant seats in B.Arch. course in Grant-In-Aid institutes for academic year 2024-25.

Following are important instructions for offline counseling on vacant seats of Degree Architecture course in Grant-in- Aid (GIA) Institutes. Candidates who are willing to secure admission to vacant seats arising after online admission process of B.Arch program at Grant-In-aid institutes for academic year 2024-25 are hereby informed to follow procedure as per following instructions and schedule.

Steps/Instructions of Participation in above stated admission process

- The candidates who are in merit list of ACPC and are willing to take part in vacant seats in GIA Institutes shall have to register online by filling registration form given in the link:
<https://forms.gle/Z8PD4VcE9NR62DDi8>
between **19.09.2024 to 22.09.2024**. It is compulsory to fill the online registration form to become eligible for this offline round of vacant seats in GIA institutes.
- Candidates fulfilling eligibility criteria as mentioned in rule-5 of admission notification for B.Arch. course who have not registered in online B.Arch. admission process of ACPC shall have to do new online registration by filling online registration form given in the link between **19.09.2024 to 22.09.2024**.
- Newly registered candidates have to pay **Registration Fee 350/- (Non Refundable) in cash** at the time of reporting on the day of counseling.
- There is no other means of applying for the candidature for this offline round of admission on vacant seats in GIA institutes, thus, candidates who do not register online as stated above with in prescribed time limit shall not be allowed to participate in this round of admission.
- The merit list shall be declared on committee's website tentatively on **24.09.2024**.
- Candidates have to carry original certificates at the time of counseling, after verification of original certificates; the eligible candidates will be allotted admission.
- If the student gets admission in Grant in aid institute, then student has to pay **1500/- token tuition fee in cash** during counseling. There is **no tuition fee for a girl candidate for admission in a Grant in aid institution**.

8. After allotment of admission to the student, it is necessary to report to that institution by 28.09.2024. If any student does not report within the stipulated time, such students will not have any claim for admission.
9. **Candidates who do not have merit number** or are yet to register in offline vacant seat counseling will be **allowed to do spot registration at 2.00 pm for the vacant seats on 24.09.2024.**
10. **If candidate gets admission in offline round then candidate has to cancel his/ her previous online round admission at institute level by himself / herself. Token tuition Fee refund will be done on the basis of Government rules.**
11. The admission shall be subject to availability of Seats in the concerned course and institute at the time of counseling subject to fulfilling of all eligibility requirements as per prevailing admission rules of Govt. of Gujarat for B.Arch Course.
12. Since this admission procedure is on vacant seats as per prevailing rule 20 of the admission notification available on committee's website.
13. The details of vacant seats are as stated above, the Eligibility criteria, Notifications for admission to B.Arch. course and other relevant details are available on committee's website.
14. It is to be noted that the above said procedure of admission is **applicable only to vacant seats after online admission process for B.Arch. course in Grant-in-aid institutes (as stated above).**
15. Only one parent will be allowed to the committee along with the candidate.
16. The candidates are advised to visit the committee's website www.acpc.gujarat.gov.in on regular basis for latest updates including notices/rules/circulars/guidelines etc. all related to admission process. The candidates can also call helpline No. **07926566000** for any queries.
